PE APPLICANT – EDUCATIONAL PLAN OF STUDY AGREEMENT

The West Virginia Board requires any exam applicant who has failed the Principle and Practice exam two (2) or more times in West Virginia or elsewhere to prepare and submit an Educational Plan of Study Agreement to be approved by the Board prior to admission acceptance being granted. This requirement for the Principles and Practice exam admission is based on WV Code § 30-13-15(d) and is intended to be informational and educational for all parties involved. The Board requires the exam applicant to develop an individualized Educational Plan of Study that includes specific valid strategies for improving knowledge in deficient areas. If unsuccessful on the exam attempt, the Board will require a review and analysis of the unsuccessful Educational Plan of Study and development of a different or more comprehensive course of action for subsequent exam attempts.

Each situation where an individual is taking the exam for the 4th time or more will be individually reviewed. The Board recognizes each situation may be unique and require a personalized plan of study / course of action that should be judged on a case by case basis. As with our continuing education program for those renewing their WV PE license each year, the West Virginia Board does not pre-approve educational courses nor do we pre-qualify companies to offer educational seminars. The Board does not plan to pre-qualify any specific exam preparation activity but rather judge each submission on its own merits, taking into account the deficient areas outlined on the individual examinee's diagnostic sheets from previous failed attempts. At this early stage of implementing the requirement of the Educational Plan of Study agreement, the Board will allow the exam applicant to develop an individualized plan of study / course of action that includes specific valid strategies for improving knowledge in deficient areas. Because of a fairly small exam pool in WV, and with each individual's talents varying to some degree, the Board will take the time necessary to review the plan and determine whether or not the selection was appropriate. If the examinee is still unsuccessful, the Board will require a different educational plan of study / course of action for future exam attempts. Since no pre-approval process is offered, the Board will make every effort to work with applicants to ensure the intent of the program is being met.
